Purpose

To provide the Program and Planning Committee with a summary of the Secondary Curriculum Services Program and Planning presentation.

Context

Secondary Curriculum Services

Content

Highlights of the Secondary Curriculum Services presentation include:

- TLDSB matched last year's average of 84% in the OSSLT.
- 78% of students in grade 10 are on track (12 credits at end of S1)
- 89% of students in grade 9 are on track (4 credits at the end of sem 1)
- 37% of students who are off track are within 1 credit of being back on track (average across TLDSB)
- 73% of grade 9 students with coaching support reported feeling more confident in their learning
- 100% of teachers who participated in a coaching cycle reflected that the coach has positively impacted student learning and/or their instruction and assessment practices
- 1009 students were impacted by the detreaming coach funding in S1

Math Action Achievement Plan:

- 71% Report an increase in their use of high impact instructional strategies
- 78% Work 1-1 with a school coach or math lead
- 82% Are using assessment by expectation to report to students
- 67% Participated in central PD
- 73% Report an increase in student achievement on their school's chosen area of focus
- 78% Report an increased understanding of inclusive instructional and assessment strategies
- 100% Use a class profile

Fenelon Family of Schools Project (Grade 7-8 Educators)

- 100% of educators reported the learning sessions supported them to improve student learning and achievement with their students
- 87% of educators felt excited, supported, or inspired by the learning session
