LONG TERM ACCOMMODATION

The purpose of a Long Term Accommodation Plan (LTAP) is to provide information on school enrolment, community demographics and future accommodations for Trillium Lakelands District School Board. This plan will allow for recommendations related to the school board and its assets including land acquisition and disposition, new school construction, additions, boundary reviews, school closure reviews and other matters related to student accommodation.

In addition to student accommodation, this plan summarizes facility conditions and renewal and/or renovation projects. The LTAP strives to be consistent with Ministry of Education policies, practices, and guidelines as well as with the Board's mission, vision, strategic plan, and policies. The aim is to ensure students have access to facilities which offer healthy, safe, and accommodating spaces while providing a quality learning environment.

The LTAP will be updated annually and provide a picture of the Board's accommodation priorities each year. Ministry funding, initiatives, and projects may impact the plan. Some portions of the LTAP provide data based collected by Statistics Canada and the census data is typically updated every four years, following a country wide numeration process. As such, this plan includes the most current data provided by their resources available at www.statcan.gc.ca.

ABOUT TLDSB

Trillium Lakelands District School Board operates in the area of three former legacy school boards. In 1998, the Muskoka, Haliburton and Victory County school boards merged to create Trillium Lakelands District School Board. The board operates three education centres; one in each legacy board.

The School Board covers three distinct regions as defined by Statistics Canada; however, the School Board is broken down into five review areas. The Statistics Canada Defined Regions are:

Kawartha Lakes Profile


The City of Kawartha Lakes is a single tiered municipality with a total population of 79,247 (2021) and an area of 3,059 square kilometres. The main population centres are the communities of Bobcaygeon, Fenelon Falls, Lindsay, Omemee, and Woodville.

Haliburton Municipal Profile

Haliburton County is made up of four lower tier municipalities with a total population of 20,571 (2021). The municipality includes the Townships of Algonquin Highlands and Minden Hills and the Municipalities of Dysart et al and Highlands East. The county has an area of 4,072 square kilometres with the main population centres of Haliburton, Minden, Wilberforce, Gooderham, and Cardiff.

Muskoka Municipal Profile

The District of Muskoka is made up of six lower tier municipalities with a total population of 66,674 (2021). There are three towns: Bracebridge, Huntsville and Gravenhurst within the District and three townships: Lake of Bays, Muskoka Lakes and Georgian Bay. The District Municipality of Muskoka has an area of 3,938 square kilometres with the main population centres of Bracebridge, Huntsville, Gravenhurst, Port Carling, Bala, Dwight, Dorset, and Port Severn.



FACILITIES

Trillium Lakelands District School Board has three education centres, seven secondary schools, 41 elementary schools (1 has closed) and six alternative education centres. Daycare facility space is available at 30 sites with services ranging from before and after school to full-day programs.

Facility Condition Index (FCI)

Facility condition assessments are carried out every five years by the Ministry of Education to assess educational buildings, components and facility systems. Systems include electrical, mechanical, architectural and plumbing elements of each building. Each system is comprised of many components. When these assessments are conducted, estimates are made on the condition and life span of the component as well as replacement timing and costs. Replacement costs represent renewal needs.

The FCI can be calculated based on the five-year renewal needs compared to the cost to replace the entire school. A high FCI indicated a high renewal need.

FCI = five-year renewal need cost building replacement cost



The FCI included in this LTAP were calculated by the Province. This data would be considered outdated; however, they are the most recent figures available. The Ministry is currently reviewing all schools in the Province and new data will be made once the review is complete.

All projections in this document were provided by Watson and Associates in May 2024, following a comprehensive review of schools, demographics, municipal planning projects etc.

Capacity

On the Ground Capacity (OTG) is the number set by the Ministry of Education to quantify the number of students that can be accommodated within a school building – this does not include portable spacing.

Government Supported Renewal and School Improvements

The Ministry of Education provides funding programs to support major repairs and renovations to Ontario School Boards – School Renewal Funding and School Condition Improvement funding. Both sources can be used for similar work but each has its own criteria for funding projects.

School Renewal Allocation (SRA) is a multi-faceted program that allows Boards to revitalize and renew aged building systems and components. This includes roof replacement and replacing of aged HVAC systems. The program also allows boards to undertake capital improvements. In addition, SRA also allows boards to address maintenance requirements such as painting, roof patching, and pavement/parking repairs.

School Condition Improvement (SCI) funding allows boards to revitalize and renew aged building components that have exceeded or will exceed their useful life cycle in buildings that boards intend to operate for at least five years beyond the date of funding. Items eligible for SCI funding will have been identified through the Ministry's School Facility Condition Assessment Program and are aimed at addressing priorities such as health and safety, building repairs, improving energy efficiencies at schools and improving accessibility.

Occasionally, the Ministry may also provide additional situational funding projects to school boards such as Climate Action Infrastructure Funding (CAIF) which recently provided School Boards with funding for projects to decrease energy usage, save money, and reduce carbon pollution.

Planning

Planning and development in the City of Kawartha Lakes South Review Area is managed by the City of Kawartha Lakes through administering, reviewing and processing development applications submitted under the Planning Act.

The City of Kawartha Lakes will undergo a substantial transformation in the coming years with two notable developments emerging, one in the west near the Lindsay Municipal Airport and the second along the Highway 36 corridor.

Developments near the airport will create between 2,000 and 3,000 housing units in the next decade. The homes built on the west side of Lindsay will impact Parkview Public School, Leslie Frost Public School, Mariposa Elementary School, Fenelon Township Public School and LCVI Secondary School.

Developments along the Highway 36 corridor may include up to 8,000 new housing units. As these housing builds complete, pressure for student spaces will impact Queen Victoria Public School, Scott Young Elementary School and Jack Callaghan Public School.

In 2024, Lady Eaton Elementary School closed as a result of a pupil accommodation plan with students moving to Scott Young Public School. Lady Eaton may serve as a holding school for new development students in the future.

It is expected that the board will submit a request for funding for a new school in both areas to support the local population and reduce the reliance on transportation.


In 2023-2024, the board underwent a boundary review to make accommodations for the potential student population influxes from the incoming housing units on the west side of Lindsay. This has resulted in an expanded catchment area for Mariposa Elementary School which currently has the capacity to absorb student population. It also affects Fenelon Township Public School. Pressure has been taken off a few of the public schools with assigning more catchment area to Mariposa Elementary School and Alexandra Public School. The board also took the step to make most schools in the town of Lindsay grades kindergarten to grade eight models. This has resulted in a shifting of populations out of some schools into others alleviating overcrowding and increasing the population in under-utilized schools

The Municipality – the City of Kawartha Lakes – passed bylaws to list four schools in Lindsay on the Heritage Registers. These actions may affect the board's ability to make repairs, upgrades and service the buildings. As well, it may impact budgets to make spaces accessible and potentially impact delivery of some parts of school.

The region is expected to grow to 117,000 people by 2051. To plan for this, the City of Kawartha Lakes has commenced an extensive review and update of their Growth Management Strategy. Commitment has been made to have TLDSB part of the consultation process for this initiative. This will ensure the school board's needs are met while providing critical input to the municipality's strategic planning.

School Enrolment and Trends

This review area is expected to experience a slight dip in enrolment and then steadily increase towards the end of the decade. At this point, the Board is not anticipating utilizing all of its facilities in accommodation.



School Composition and Capacity

The Board has capacity to accommodate approximately 5,600 elementary students and approximately 2,500 secondary students in this area.

Enrolment across the 13 elementary schools is approximately 4,000 students.

Currently, facility utilization is at approximately 73% and will near capacity within the next 10 years.

Housing developments necessitate the consideration of new schools in more geographically appropriate areas such as the aforementioned developments in the Town of Lindsay. The Board is looking to source funds for a potential purchase of a parcel of land in the west part of Lindsay to help with replacing costly and aging buildings, and the increased population in the region.

As well, some of the facilities within the Board portfolio in City of Kawartha Lakes South are significantly old and will present challenges going forward such as accessibility as well as in the ability to cool or heat the buildings effectively. Many facilities in this region will require significant investments as they may not be able to be updated due to heritage designations established on the facilities by the City of Kawartha Lakes.

In 2024, schools in this region were subject to changes as a result of two boundary review, both approved by the Board prior to implementation. Mariposa Elementary School and Dr. George Hall Public School had boundaries amended to better match the growth of the community and a more linear boundary. As part

of this review, one minor change was made to one road in the Jack Callaghan Public School catchment area.


The second boundary review in 2024 was a restructure of the schools in the core of Lindsay including Parkview Public School, Central Senior School, Fenelon Township Public School, King Albert Public School, Leslie Frost Public School, Mariposa Elementary School, and Queen Victoria Public School.

A transition to an English kindergarten to Grade 8 model for Alexandra, King Albert, Leslie Frost (English stream), Parkview and Queen Victoria schools over the 2024-2025 and 2025-2026 school years. All schools part of the review had changes to their boundary catchment areas with the exception of Queen Victoria.

In 2024-2025, a program review of the French Immersion grade distribution at Leslie Frost Public School and Central Senior Public School to look at balancing school enrolment and capacity, each school's facilities, programs offered and any limitations at either school. The recommendation will be to have French Immersion programming for Grades 1 to 3 remain at Leslie Frost Public School and Central Senior will welcome Grades 4 to 8.



South Boundary: The southern limits of the former Town of Lindsay.




South Boundary: Beginning at the southwest corner of Lot 1, Concession C of the former Mariposa Township and following the north shoreline of Lake Scugog, including Washburn Island and Ball Point, to where the boundary between the former Mariposa Township and Ops Township meets.


School Composition and Capacity

At this point, there is no anticipated need for facility alterations or boundary reviews for this area.



Planning

The County of Haliburton is a large geographic area with a two-tier government structure made up of the County and four lower tiered municipalities. Planning and development in the Haliburton Review Area is managed at each of the lower tiered municipal offices; however, plans of subdivision, condominiums and consents are processed by the upper tier – the County of Haliburton.

There are no large-scale home building projects anticipated within this review area. The area tends to have a fairly stable population despite lack of growth and housing.

School Enrolment and Trends


Currently, there are approximately 1,700 students among the five elementary schools with the capacity of approximately 2,400 people places. The enrolment is expected to stay stable for the for seeable future.

Facility utilization in this review area is approximately 66% and provides a bit of a challenge to the Board. There are two schools with enrolment under 100 which makes it difficult to staff and program effectively for those individual schools.


Archie Stouffer Elementary School is expected to be slightly over capacity in the mid to late part of the decade but not enough to warrant an addition to the school. In this instance, portable classrooms may be considered to expand capacity at the school.

In the secondary panel, Halliburton Highlands Secondary School continues to have fairly stable enrolment with student count being from the low 400s up to the high 400s. The building has capacity of 675 which means the Board will not be requiring any additional space and programming should be well contained within this building.

Planning

Planning and development in the Muskoka North Review Area is managed at each of the lower tiered municipal offices (Huntsville and Lake of Bays); however, plans of subdivision, condominiums and consents are processed by the upper tier – the District Municipality of Muskoka.

School Enrolment and Trends

The long-term plan for the Muskoka North region is mixed. While medium size housing developments are taking place on the northwest side of the town, there has not been a corresponding increase in student population. In the short and medium term, the Board will not require any additional space and will retain all existing property in anticipation of future builds. Enrolment is strong at all the elementary schools, but there is no current requirement for investments in facilities in terms of additions or modifications to buildings.

The Board acknowledges the need for child care is increasing in this region. The Board works with local providers in the District to provide guidance and support with respects to child care services. There is a potential to increase the quantity of daycare spaces within the Town of Huntsville.

School Composition and Capacity


The board has a capacity for 2,300 students across the elementary schools in Muskoka North with a current average daily enrolment of approximately 1,900 students. The facility utilization rate is close to 82% with an expectation to move to 93% within three to five years.


All facilities in this region, with the exception of Irwin Memorial Public School, have enrolment in excess of 200 students which creates a healthy school community. Irwin has a capacity of 211 but only an average daily enrolment of a proximity 140 students.

In 2024, a program review resulted in changes to the French Immersion grades at Riverside and Huntsville Public Schools. Grade configuration changes will take place in the fall of 2024 and 2025.

There are no anticipated enrolment pressures in the Muskoka North region; however, if there are, the Board will be able to manage these pressures through school boundary review.


Huntsville High School has a healthy enrolment and there are no plans for alterations or expansions of the facility at this point in time.

Planning

Planning and development in the Muskoka South Review Area is managed at each of the lower tiered municipal offices (Bracebridge, Gravenhurst, Muskoka Lakes, and Georgian Bay); however, plans of subdivision, condominiums and consents are processed by the upper tier – the District Municipality of Muskoka.

There are some developments in the Bracebridge and Gravenhurst areas that may create some possible pocket pressures on some schools, but these can be alleviated by school boundary reviews and possible portable use. Bracebridge is an area of potential review given the developments around Monck Public School and Manitoba Street north.

School Enrolment and Trends

The board has capacity for 3,150 students across these elementary schools with a current average daily enrolment of approximately 2,700 students. Facility utilization rate is close to 87%.

School Composition and Capacity

Muskoka Beechgrove Public School is the school in this area with enrolment which needs monitoring as the current average daily enrolment exceeds the capacity. The enrolment amount exceeded is not by an amount that the Ministry of Education would consider funding a school addition; however, it may necessitate consideration of a boundary review and or grade configuration change in the future.

In terms of school size there are two schools, Glen Orchard Public School and Honey Harbour Public School which fall below the 150 pupil threshold. K.P. Manson Public School's population is slightly above the 150 threshold. Unfortunately, due to the distances between these three elementary schools, an accommodation review is not a solution at these sites.

The projections to 2028 have a slow growth for Glen Orchard Public School to approximately 265 students.


Honey Harbour Public School continues to generate an expected 40 to 60 students annually through 2028 and provides the only education destination for the students in proximity to the school. The towns of Honey Harbour and Port Severn are the small communities close to this school.


The Board will have to continue to monitor the health and financial support of Honey Harbour Public School in order to make sure that there is a viable program for students in that area of the Board while at the same time, not jeopardizing the financial health of the Board and providing continued educational support in the community.

Bracebridge Public School and Monck Public School may be a potential boundary review area given the developments in Bracebridge.

In the secondary panel, Gravenhurst High School continues to maintain an enrolment between 300 and 350 students which makes it difficult to provide meaningful programming to the students without compromising resources at the secondary level across the system. Bracebridge Muskoka Lakes Secondary School has experienced an uptick in enrolment and is expected to reach 1000 students within 5 years.


The secondary schools in South Muskoka will require an extensive review in the next few years. Among the considerations in the long term for Gravenhurst High School may be a Grade 7 to 12 configuration taking in students from both Gravenhurst Public School and Muskoka Beechgrove to alleviate pressure on those schools.

BOARD PROGRAMMING

French Immersion

A Framework for French as a Second Language (FSL) in Ontario Schools, Kindergarten to Grade 12 was released in February 2013 as an overarching strategic 10-year document that serves as a call to action and a guide to strengthen FSL programming through the cohesive efforts of educators, students, parents/guardians, and communities.

The Provincial Framework articulates:

The vision for FSL in Ontario

Students in English-language school boards have the confidence and ability to use French effectively in their daily lives.

The goals for FSL in Ontario

- Increase student confidence, proficiency, and achievement in FSL.
- Increase the percentage of students studying FSL until graduation.
- Increase student, educator, parent/guardians, and community engagement in FSL.

The FSL curriculum strives, ultimately, to foster an interest in language learning that continues not only during a student's time in school but later in life. The FSL curriculum is therefore founded on seven fundamental concepts, or "enduring ideas," which focus, from Grade 1 to 12, on the development of skills that are also necessary as a basis for lifelong language learning. These enduring ideas are:

- Authentic oral communication: reception, production, and interaction.
- Listening, speaking, reading, and writing: interconnected but distinct.
- Development of language learning strategies.
- Interdependence of language and culture.
- Emphasis on critical and creative thinking skills.
- Goal setting and reflection
- Making real-world connections.

The vision for FSL at TLDSB

Trillium Lakelands District School Board (TLDSB) French Immersion Programs are inclusive and accessible to all students within the Board, in hopes that graduating students of the French as a Second Language (FSL) Program will be able to communicate and function at a certain level of French proficiency that will enable them to pursue work or post-secondary education in French.

The goals for FSL at TLDSB

In all FSL programs, students realize the vision of the FSL curriculum as they strive to:

Use French to communicate and interact effectively in a variety of social settings.

- Learn about Canada, its two official languages, and other cultures.
- Appreciate and acknowledge the interconnectedness and interdependence of the global community.
- Be responsible for their own learning, as they work independently and in groups.
- Use effective language learning strategies.
- Become lifelong language learners for personal growth and for active participation as world citizens.
- Recognize the relevance of Common European Framework of Reference for Languages (CEFR) practices and see themselves along the learning continuum.

All of our FSL programs align their practice with the goals of the CEFR, which will ultimately lend itself to our students successfully attempt the *Diplôme d'Études en Langue Française* (DELF) proficiency exam in Grade 12.

In order to achieve the goals of the elementary and secondary FSL curriculum, students need to acquire a strong oral foundation in the French language and focus on communicating in French.

A student's French proficiency skills may be maximized as the amount of instructional time and level of intensity are significantly increased. The amount of instructional time taught in French in each grade level is as follows:

• **Grades 1-3** – 60 percent of instructional time is taught in French. The remainder of the time is filled depending on staffing and school-based decisions.

^{**} Effective 2025, Leslie Frost Public School will have FI programming at Grade 1

^{***} Effective 2025, Central Senior School will have FI programming from Grades 4 to 8

- **Grades 4-6** 60 percent of instructional time is taught in French. Math and an English language period are introduced, but the remainder of the English allotment is filled depending on staffing and school-based decisions.
- **Grades 7-8** 50 percent of instructional time is taught in French. Math and an English language period are introduced, but the remainder of the English allotment is filled depending on staffing and school-based decisions.

Secondary Programming

Special Education

Trillium Lakelands District School Board (TLDSB) recognizes that every student is unique and that each student must have opportunities to achieve personal success according to interests, abilities, and goals. The Board's priority is to provide the best possible learning opportunities and supports for all students with a commitment to ensuring that high quality programs and services are in place for all students with special education needs.

In TLDSB, Special Education consists of the programs, services, resources, and professional development of staff that will ensure opportunity for students with special needs to reach their full potential. Opportunities to learn, progress, and achieve must be available for all students, in compliance with the Canadian Charter of Rights and Freedoms, the Ontario Human Rights Code, the Education Act and regulations made under the act, and any other relevant legislation All teachers share responsibility for providing high quality education opportunities for every student in their charge.

The education of students with special needs is a joint effort between home and school. The most effective special education program is one that combines the support of the parents/guardians with the resources of the school and the community. By working together as a team, a shared vision for the student can be developed and education goals prioritized. Our guiding principles for Special Education programs and services for students with special needs align with the Ministry of Education Learning for All beliefs:

- All students can succeed.
- Each student has his or her own unique patterns of learning.
- Successful instructional practices are founded on evidence-based research, tempered by experience.
- Universal design and differentiated instruction are effective and interconnected means of meeting the learning or productivity needs of any group of students.
- Classroom teachers are the key educators for a student's literacy and numeracy development.
- Classroom teachers need the support of the larger community to create a learning environment that supports all students.
- Fairness is not sameness.

We use a Staged Response to Intervention (RTI) approach as a framework to guide the practice of providing high quality instruction and intervention based upon individual student needs.

Core Program (Tier 1)

- High expectations and quality programming for all students
- Assessment and instruction are planned in relation to the curriculum for all students.
- The teacher observes, monitors student progress, and notes which students may be experiencing difficulty;
- The teacher responds to learning needs by adjusting teaching strategies;
- Responsive instruction is available to all learners;
- Examples include: Curriculum, Universal Design for Learning (UDL), Differentiated Instruction (DI)

Supplemental Program (Tier 2)

- When the teacher discovers that a student has a learning gap in a particular area, a precise program is planned to close the learning gap;
- Student progress in response to these supplemental interventions is closely monitored and instruction is adjusted, as needed;

- Supplemental interventions may occur in the regular classroom setting or in a withdrawal setting for some student;
- Examples may include: responsive reading, small group intervention to target the lagging skill, Student Success or Resource Room Support with a specific program to close the gap.

Specialized Program (Tier 3)

- At times, students require intensive support to achieve learning goals;
- A few students require more intensive, precise and personalized assessment and instruction focused on closing learning gaps;
- The teacher is supported by the in-school team and/or system resources to develop the most effective program plan;
- Student progress in response to these intensive interventions is closely monitored and instruction is adjusted, as needed;
- Examples may include: Highly specialized program supported by the Behaviour Intervention Resource Team; Special Program Placement, Psycho-educational Assessment, Speech and Language Services.

Daycare

The Board offers day care at many of the elementary schools across and continually seeks opportunities to engage our community partners in providing daycare services for infant and before and after school care to support our communities.

Superintendents meet with District Area Childcare Managers at the Municipalities who are responsible for childcare in their regions in order to assess opportunities for additional daycare opportunities within our schools.

The Board, along with the District Area Childcare Managers, have worked on the vision of childcare going forward whether it may be included in school design or exist as standalone buildings. Decisions in these would be contingent upon the funding made available from the Province to support a model that they deem most cost effective.

The advantage in a standalone facility would be that the daycare could operate independently of school operations and allow the board to close their school in a timely fashion if there is not community use during the evening while the daycare could continue to operate beyond those hours.

When there is increased demand for before and after child care in an area without any before and after school programs, the Board will conduct a viability survey in order to determine demand and viability. If there appears to be enough demand to support a new before and after child care program, the Board will contact existing child care providers in the area and they will conduct a second viability study. If, after the second viability study, there is enough demand to successfully run a program, the child care provider will then go through the license and permit process in order to put a program in place.

See APPENDIX C for a listing of all current daycares provided at Board facilities.

Community Partners

The Board supports the use of unused long-term space at schools to support community uses where appropriate and as appropriate within our buildings. The Ministry has the expectation that the school boards operate these space use leased areas on a cost recovery basis.

TLDSB welcomes any community member or group who might be interested in a long-term arrangement with the Board. The criteria for a school to consider a long term leased space is as follows:

- building capacity between 65% and 80%
- is not subject to a long-term accommodation review
- has enrolment which exceeds 150 people

The Board would also offer opportunities in buildings that are on the perimeter of the board in more remote and far-reaching areas to abutting community groups or individuals.

TLDSB encourages a wide variety of community groups to access the Board's school facilities. A standard fee structure has helped to support programming in a wide range of interests and helps support the local community. The Board strives to ensure that a variety of groups and not just one or two are able to access any individual building during a week

In 2023-2024, there were 195 long term permits at 41 schools.

Out of Bounds Students

As part of the Long Term Accommodation Plan, the Board is committed to looking at having students remain within their home schools in the District. The Board realizes there may be certain circumstances that require a student to attend a school that is not within their catchment area and will work through those situations on an individual basis.

The availability of child care within a catchment area dictates where the student enrolls in school. This often creates enrolment pressures at some schools while creating a lack of programming availability due to low enrolment at other schools.

The Board will be developing an appropriate out-of-bounds policy and procedure to address this with limited exceptions that students will attend their home school within their catchment in order to support the local programming at that school.

In the secondary level, the Board will continue to operate under the premise that students should attend the school within their catchment area; however, if there is not French Immersion or Specialist High Skills Major (SHSM) programming at their home school, students may attend a school outside their catchment area for as long as they are enrolled in that program.

APPENDIX A – FACILITY CONDITION INDEX BY AREA

The Ministry of Education provides the following information regarding school Facility Condition Index (FCI).

The Facility Condition Index is a warehouse of data on each and every school's state of repair. Information on the condition of Ontario schools is gathered in five-year cycles. To get detailed information, the Ministry of Education hires independent, third-party facility inspectors. Each assessment team is comprised of two engineers — one with expertise in building design and construction, and the other with expertise in building systems (e.g., mechanical and electrical).

The inspectors review essential structures and systems for each school building as well as wear and tear to building interiors. Based on the findings, the Ministry can determine a school's repair and renewal costs. The cost of a school's repair and renewal needs are then compared against the cost of rebuilding that same school from the ground up. The results of this comparison give the school its FCI, which is measured as a percentage.

It should be noted that the ratings are a snapshot in time as of the date of inspection. The renewal needs and FCI rating can vary from the time of assessment for many reasons, such as investments made by a board to address renewal needs since the inspection.

A school with a low FCI rating needs less repair and renewal work than a school with a higher FCI rating.

Ontario has nearly 5,000 school buildings, the average age of which is 39.4 years old. Some of these buildings date back to the late 1800s and early 1900s. The older a building is, the higher its repair and renewal needs will likely be.

GLOSSARY OF TERMS

Boundary Review

A review conducted by the Board to review the attendance area for a school or group of schools due to changes in student enrolment, program demands, new school construction or other factors. These reviews are needed to help balance school enrolment and capacity, minimize busing and maximize walk zones for schools.

Before and After School Care

Before and after school programs are offered in schools to provide support to families by offering supervised activities before and after the hours of the school day. Parents are able to drop off their student before the school day and are able to pick up their student after the end of day bell.

Capital Priorities

Capital Priorities are funding programs for construction projects that are carried out at schools and board offices. Capital planning is an ongoing process that identifies capital priorities such as new schools, additions and renovations.

Child Care Centre

Many of the Board's schools have child care centres situated within them. These are full-time daycare programs which are offered by licensed third parties who lease space from the Board. TLDSB does not have any child care centres that are operated by the Board.

Education and Community Partnership Program (ECPP)

This partnership program provides support to meet the needs of children and youth who cannot attend school due to their primary need for care, treatment, or rehabilitation services. They are partnerships between the Board and government approved facilities (such as children mental health agencies or youth detention centres) where the Board provides the education component with the facility providing the care, treatment, or rehabilitation.

Dual Track (DT)

Schools with Dual Track programming offer both English and French streams of education.

English as a Second Language (ESL)

This is a program designed to help students who do not have English as their first language. Through the program students are taught a variety of language skills with focus on speaking, listening, reading, and writing to give students a well-rounded understanding of the English language.

Facility Condition Index (FCI)

This index is created by the Provincial Government and is used to assess educational buildings, components and facility systems and provide estimates for condition and life span of the components and systems. It is calculated based on the cost of a five year renewal need compared to the cost to replace the entire school.

French as a Second Language (FSL)

As one of Canada's two official languages, French is taught in Ontario's English language school boards. They are programs for all students in elementary school with a minimum offering at the Grades 4 to 8 level. Ontario students are required to take one FSL course at the secondary level in order to obtain their diploma.

French Immersion (FI)

Students learn French as a subject and it is the language of instruction in two or more other subjects taught. In elementary schools, 50 per cent of all instruction is provide in French. In secondary schools, academic, applied, and university level courses are offered to students where they ear ten French credits.

Full Time Equivalent Student (FTE)

This is a unit of measure equivalent to a student's amount of time attending schools. An FTE is a student who attends school on a full-time basis.

Gross Floor Area (GFA)

This is the total square feet that is measured between the exterior surfaces of a building or structure's enclosed fixed walls.

International Baccalaureate Diploma Program (IBDP)

International Baccalaureate (IB) is a standardized global diploma program (DP) offered around the world for students aged 16-19. This program is offered at I.E. Weldon Secondary School.

Long Term Accommodation Plan (LTAP)

The long term accommodation plan is a planning document to help guide capital investment, program and facility decisions that support the vision for the Board as set out in its strategic plan.

On the Group Capacity (OTG)

This is the number set by the Ministry of Education to quantify the number of students that can be accommodated within a school building (not including portables).

Out of Boundary (OOB)

An out of bound student is a student who is attending a school that is not their home school. In some situations, students are accommodated at schools out of their home school bounds so they can participate in a specific program (like FSL or Specialist High Skills Majors) that is not available at their home school.

Out of District (OOD)

An out of district student is a student who is attending a TLDSB school who does not reside in the Board boundaries. Like an OOB student, these students come to a TLDSB school to participate in specific programming. If the student is no longer participating in the programming, they must return to their home school within their home board.

Pupil Accommodation Review

A review which studies a significantly under-utilized school or group of schools to consider ways to reduce surplus space and ensure students have access to viable programs which may result in the movement of students between schools or potential school closures.

Review Area (RA)

The Trillium Lakelands District School Board has five review areas: RA1 – City of Kawartha Lakes South, RA2 – City of Kawartha Lakes North, RA3 – Haliburton, RA4 – Muskoka North, and RA5 – South Muskoka

Special Education (Spec-Ed)

Special Education are programs and services providing instruction and assessment that is different from those provided to the general student population to accommodate behavioural, communicational, intellectual, or physical exceptionalities.

Total Capacity

The total capacity at a school is the number of students who can be accommodated at a school based on the Ministry's on the group capacity combined with space that the school has with portables.
