5. Administrative updates

- 5.1 Mental Health Presentation Superintendent T. Fraser & District Manager A. Jones
- T. Fraser and A. Jones outlined the mental health services and initiatives planned for students and staff within TLDSB, including various intervention programs, training, and strategies for promoting mental health awareness. The Mental Health team emphasizes a comprehensive approach to supporting mental health, from direct counselling to system-wide capacity building and community partnerships.
- 5.2 System updates
- N. Train shared the following updates:

- Clarification regarding a recent miscommunication about changes to the Practical Academics & Life Skills program at the Lindsay Collegiate & Vocational Institute. The school issued an apology and confirmed that they have sufficient sections and educational assistants.
- To better support students with autism and build capacity among classroom teachers, two new autism facilitator positions will be created. This initiative aims to address the rising number of students diagnosed with autism.
- To address summer learning gaps, summer learning funding will support the curriculum department's summer program. Funds will also be used to provide two days for system classes to host in-school family meetings. Financial support will also be extended to Wahta's participation in the program, covering their expenses which they previously selffunded. Remaining funds will be allocated to resources for the new system classes.

Recent staff hires include classroom teachers for system classes, a new secondary special education consultant, and the permanent hiring of a temporary Psycho-educational consultant.
